#### Signage

- Monitored and reviewed daily, including location, replacement and wording
- Thank you to those in the community helping with this either by retrieving signs from hedges or notifying us

#### Gatemen

- Area of major concern at the last meeting
- Received positive feedback for our gatemen and they are being relocated around the area as and when needed, recently supporting Leeds Castle's event at the weekend.

#### Schools returning

- Significant concern last meeting about schools returning
- Worked with Leeds and Broomfield Primary to allow their minibus access

#### Permits


- Introduced for residents mainly on Upper Street, Lower Street, Forge Lane, Caring Lane and Back Street

#### Surrounding roads beyond closures

 We have reviewed these with Kent Highways to add signage where possible, but no further changes are planned

#### Site update

- Progress is a month ahead of programme
- First section was directionally drilled
- 250 metres have been laid with 26 services connected
- Two connections made to existing network
- Closure has extended to Forge Lane
- The team have been digging trial holes to assess the possibility of drilling a further section
- Switched off old main near Horseshoes Lane.



#### **Review of Traffic Management**

- Purpose of this meeting is to review any new traffic management issues that have arisen in the two weeks since schools have returned from the summer break
- Aim of the traffic management is to ensure traffic flows and is not causing congestion
- We've been constantly reviewing the traffic management and balancing the needs of the community
- Wider community are now aware of the situation and so any changes made now are likely to add to the disruption
